NEWS FROM THE REFUGEE COUNCIL

Election of new government brings portfolio and policy changes

The Liberal-National Coalition has reshuffled portfolio responsibilities and begun implementing new asylum policies following its victory in the Federal election held on 7 September. Under the changes, the old Department of Immigration and Citizenship has become the Department of Immigration and Border Protection (DIBP), with its work focused on border control, entry to Australia (including entry for asylum seekers and resettled refugees) and citizenship. The new Minister is Scott Morrison and his Assistant Minister is Senator Michaelia Cash. Responsibility for settlement services and multicultural affairs has been shifted to Department of Social Services under Minister Kevin Andrews and his Parliamentary Secretary, Senator Concetta Fierravanti-Wells. Responsibility for the Adult Migrant English Program is moving to the Department of Industry, under Minister Ian McFarlane and Parliamentary Secretary Bob Baldwin. DIBP will retain responsibility for the care of unaccompanied refugee and asylum seeker minors, with settlement support shifting to the Department of Social Services once they turn 18. DIBP will also retain responsibility for "ethnic affairs" (as opposed to "multicultural affairs"), keeping some community liaison officers to respond to migrant and refugee diasporas on migration, status resolution and other matters under the Immigration portfolio. From September 18, the day the new Ministry was sworn in, the Government's Operation Sovereign Borders was implemented. Under Operation Sovereign Borders, the Royal Australian Navy is under orders to turn back asylum boats to their origin where it is safe to do so and asylum seekers arriving by boat will be sent to expanded offshore processing facilities on Nauru and Manus Island in Papua New Guinea. RCOA is seeking meetings with the new Ministers and Parliamentary Secretaries with responsibility for policies related to refugees and asylum seekers. The first meeting is with Senator Cash on 18 October.

Policy Brief: Temporary Protection Visas

RCOA has published a Policy Brief to explain the Coalition Government's policy to reintroduce Temporary Protection Visas (TPVs) for asylum seekers who arrived in Australia by boat and are found to be refugees. The Policy Brief provides background, analyses the Coalition's election policy commitments and summarises research about the negative impact of TPVs. RCOA is concerned that the TPV policy will punish people who have been found to be in need of refugee protection, purely because of their mode of arrival. RCOA launches consultations on Refugee and Humanitarian Program

RCOA will start its national consultations on the future of Australia's Refugee and Humanitarian Program this month. This year, RCOA's consultations with service providers, refugee community members and interested members of the public will be held in eight states and territories. These consultations inform RCOA's annual submission to the Minister for Immigration and Citizenship on issues the Australian Government should consider in planning the coming year's refugee program. RCOA has produced a discussion paper to assist people participating in the consultations. The schedule

Executive Committee of UNHCR discusses critical refugee protection challenges

In the lead-up to the annual Executive Committee meeting of the United Nations High Commissioner for Refugees (UNHCR) in Geneva, RCOA outlined the key refugee protection challenges that should be central to discussions. The five-day meeting brought together representatives of the 87 nations which make up the UNHCR Executive Committee. RCOA president Phil Glendenning attended the meeting as an NGO observer on the Australian delegation. In a statement prior to the meeting, RCOA chief executive officer Paul Power said that, while the humanitarian crisis in Syria would dominate discussions, a number of other issues required urgent attention, including: the need to encourage the world's wealthiest nations not to turn their backs on refugees; cooperating on a regional level to protect refugees; and developing alternatives to detention. The statement said providing prompt access to refugee status determination procedures was an urgent priority, particularly in the Asia-Pacific region where many people attempting to seek asylum struggle to get access to any form of refugee status determination process or face very lengthy delays in their asylum process. RCOA said Australia, as a major resettlement country, Refugee Convention signatory and current chair of the United Nations Security Council, was well-positioned to provide leadership and support in finding better answers to global refugee challenges and ways of improving the lives of refugees and asylum seekers living in appalling conditions throughout the world. Literature review on housing for refugees and asylum seekers

RCOA has published a literature review on housing issues for refugees and asylum seekers in Australia as part of national research it is now undertaking. The literature review looks at research published on the housing challenges facing refugees and asylum seekers, including: homelessness, housing affordability, the private rental market, discrimination, appropriate accommodation, challenges facing asylum seekers living in the community on bridging visas and strategies to support refugees to find sustainable housing. In July 2013, RCOA received funding from the Geddes Nairn Development Fund, through the Australian Communities Foundation, to conduct research into current housing issues for refugees and asylum seekers. RCOA to hold its AGM in Canberra for the first time

The national and implications of changes to Australian refugee policy will be the topic for discussion when RCOA holds its 2013 Annual General Meeting (AGM) and Members' Forum in Canberra on Tuesday 26 November. The AGM will be held from 1pm at the Asia Pacific College of Diplomacy, Hedley Bull Centre, Australian National University (ANU), corner of Garran Road and Liversidge Street, Acton. The members' forum on refugee policy will begin at 2.30pm, with guest speakers to include UNHCR Regional Representative, Richard Towle, and Professor Pene Mathew of the ANU. This will be the first AGM in Canberra in RCOA's 32-year history. RCOA has been holding its AGM in different cities since constitution changes several years ago made it more possible to meet the required quorum of members
